# NHPCU Loan Rate Match Program-

The NHPCU will offer to match verifiable auto loan rates offered to its members by any New England bank, credit union, or indirect financing participations funded or repurchased by credit unions and banks in New England. New England is defined by the following 6 states: NH, VT, ME, MA, CT and RI.

Members must provide verification of the rate they have been offered from another New England financial institution or indirect loan through lenders in New England.

Member must use or open two or more of the following services: checking account, debit card, Automatic loan payment at NHPCU, or Direct Deposit to NHPCU. (existing NHPCU loans are not eligible.)


Loans financed with another New England lender or through


What do you do?!!?

# **Security Code Word/Phrase**


We are constantly trying to protect our members. We strongly suggest adding a Security Code word or phrase to your account.
